PRIVACY STATEMENT

Your privacy is important to DialogLoop. This privacy statement provides information about the personal information that DialogLoop collects, and the ways in which DialogLoop uses that personal information.

Personal information collection

DialogLoop may collect and use the following kinds of personal information:

- information about your use of this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views;
- information that you provide using for the purpose of registering with the website and login into the website
- information about transactions carried out over this website
- information that you provide for the purpose of subscribing to the website services
- any other information that you send to DialogLoop

Using personal information

DialogLoop may use your personal information to:

- administer this website;

Securing your data

DialogLoop will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.

DialogLoop will store all the personal information you provide on its secure servers.

Information relating to electronic transactions entered into via this website will be protected by encryption technology.

Cross-border data transfers

Information that DialogLoop collects may be stored and processed in and transferred between any of the countries in which DialogLoop operates to **enable** the use of the information in accordance with this privacy policy.

Cookies

We use cookies on this website. A cookie consists of information sent by a web server to a web browser, and stored by the browser.
